



International Puppy LLC Event Vendor Contract

The Parties to this contract are the International Puppy LLC, "IPC" (herein-after referred to as the "Host") and _____ (herein-after referred to as the "Vendor").

International Puppy Contest on July 6 - 9, 2017, beginning at 5pm. The Host has the right to license Vendors to vend at and during the event. The event dates and times are July 6, 2017 9pm to 2am, July 7, 2017 12pm to 2am, July 8, 2017 9am to 2am.

Vendor desires to vend _____ at and during said Event.

Vendor shall pay to the Host the sum of \$50.00 or a Gift Basket valued at \$50.00 for this said Event.

Now, therefore, all parties agree to the following:

1. Vendor will receive a Full page ad 5"x8", Vendor must provide their ad for the program booklet in either PDF, JPEG or PNG format. If vendor needs an advertisement created Puppy Graphics can provide an ad at an additional cost. All ads are to be emailed to Joe@puppygraphics.com no later than June 25, 2017.
2. Vendor is responsible for providing its own Tables, seating, extension cords, and lighting, and their own way for accepting credit cards. IPC or IPTC does not provide Internet access. JJ's Clubhouse & Bar does offer free wifi where available but is not responsible for vendors connection.
3. Vendor shall have access to their location assigned to them, no less than 1 hours before the Event's Commencement for the purpose of setting up Vendor's vending station, goods, and other things necessary and reasonable to vending at the location.
4. Vendor shall not vend any goods or services other than those described herein at and during the Event without the Host's written consent.
5. Vendor's staff may announce the availability of the goods to be vended only while they are within the confines of the vendor's location.
6. Vendor's Staff shall be clothed and groomed in a clean, neat fashion and shall conduct themselves in an orderly fashion.
7. No loud music, noise, or sound amplification devices shall be used by vendor's staff at the location.
8. Vendor shall have access to the location for up to 2 hours after the Events conclusion to dismantle and remove all things brought to the location by Vendor. Vendor shall leave the location clean of trash and substantially in the condition it was before Vendor occupied it.
9. Vendor hereby agrees to indemnify and hold harmless the Host and/or JJ's Clubhouse against any damages or claims that might arise in connection with Vendor's presents at the Event and or Vendor's activities of any kind.
10. IPC and/or JJ's Clubhouse is not liable for any loss or damage & will not be responsible for any personal injury to the Vendor, their associates and/or merchandise. The Vendor hereby agrees to indemnify, hold harmless and defend the above name entities and IPC and/or JJ's Clubhouse from any acts or omission to the acts of the Vendor, its employees, agents and assigns.

11. Vendors are responsible for any damage they may have caused while participating in the weekend's events.
12. Termination of this agreement by the undersigned Vendor results in the host retaining 100% of the vendor's payment. There will be NO REFUNDS. Payments described will be retained as liquidated damages. All tax liabilities and permits are the sole responsibility of the Vendor.
